- a) Review of Business Plan which should be done at least once a year
- b) Population of Planning sheet template (provided in a flash drive) by all Portfolio Directors with at least 3-4 four key deliverables for 2017 including budget for the deliverables. All to send to the Secretary for collation on or before December, 31st 2016. Will be tracked for 2017
- c) The City will pay for any life cycle report after the Ice Rink is completed. It consists of what the Association might need in the next 5 years.
- d) The Association must adhere to the 50% Public use policy when the Ice Rink is completed or any future recreational facility.
- e) Copy of the Policy will be sent to the President
- f) Only an inside 3rd party advert is allowed for the Ice Rink as outside advert will require the City of Calgary Management's approval.
- g) Need to review the Mandate document after the Rink is completed
- h) Conflict of Interest statement can be included in every Board Agenda to keep members on the alert when making decisions
- i) The President to circulate draft Policies and Procedures in development for members' feedback before finalising them.
- j) Need to review the Association's bylaws as current one is dated 1997

A job description template to be developed and filled by all Volunteers of the Association. Patience to send a draft templet to Muoi and Joanna for finalization and use by the Association going forward.
