Remembrance Day Facts

• Remembrance Day commemorates Canadians who died in service to Canada from the South African War to current missions. It is held every November 11.



• The first Remembrance Day was conducted in

1919 throughout the Commonwealth. Originally called Armistice Day, it commemorated the end of the First World War on Monday, November 11, 1918, at 11 a.m.: the eleventh hour of the eleventh day of the eleventh month From 1923 to 1931, Armistice Day was held on the Monday of the week in which November 11 fell. Thanksgiving was also celebrated on this day.

- In 1931, MP Allan Neill introduced a bill to hold Armistice Day on a fixed day—November 11. During the bill's introduction, it was decided the word "Remembrance" would be used instead of "Armistice." The bill passed and Remembrance Day was first conducted on November 11, 1931. Thanksgiving Day was moved to October 12 that year.
- The poppy is the symbol of Remembrance Day. Replica poppies are sold by the Royal Canadian Legion to raise money for Veterans.

How Should The Poppy Be Worn?

The Royal Canadian Legion suggests that the poppy be worn on the left lapel of a garment and / or as close to the heart as possible.



The official start of the

Poppy Campaign and the distribution of poppies to the general public begin on the last Friday in October and run until November 11.

The lapel poppy may be worn throughout the whole of the remembrance period and is removed at the end of Remembrance Day. Many people place their poppy at the base of the cenotaph, as a sign of respect, at the end of the Remembrance Day ceremony.

How to Report a Crime

Reporting crimes committed against you or someone else is an important part in helping to keep yourself, your loved ones and your community safe. If you have information about a crime that has been or may be committed or about someone involved in committing a crime, your information may help the police solve crimes and prevent future crimes from happening.

You can report a crime in person, over the telephone and online. Depending on the urgency, choose the method that best suits your situation and makes you feel most comfortable.

- Non emergency crimes can be reported by calling the non-emergency line
- The Calgary Police Service encourages Calgarians to report all crimes, in order to identify trends and better direct their patrols

In Our City Green Line LRT Update

As the largest infrastructure investment in Calgary's history, with \$5.5B in unprecedented contributions from all three levels of government, the Green Line LRT will shape mobility for generations.

Phase 1 of Green Line, from Shepard to Eau Claire, will connect the Southeast to Downtown and into the existing Red and Blue lines and



four MAX BRT routes building 13 stations, 18 km of LRT track and three park and ride facilities.

This phase alone delivers almost 20,000 new direct and supporting jobs, provides new LRT access to Calgarians through more than 50,000 daily boardings and removes 26,750 GHGs annually. The economic impact of this investment will directly benefit local contractors, trades and suppliers while delivering over \$2.2B in long-term city-shaping benefits.

When people ask "when is Green Line construction starting", the answer is that it has. Constructing mega projects, like Green Line, starts with early works construction to make way for the main infrastructure.

Phase 1 early work includes over \$300 million in utility, road, sidewalk, pathway and other infrastructure upgrades and projects such as remediation of two landfill sites and a tunnel under existing railway tracks. Early works in the southeast are complete with the focus now on the Beltline and Downtown.

The Green Line is a long-term investment in Calgary's future and as our city grows, we will make sure we all can live, work and play in sustainable and affordable ways. For more information and to sign-up for updates, visit calgary.ca/greenline.

Business Improvement Areas: Online Map Shows Calgary's Business Improvement Areas (BIA)

id you know that Calgary has 15 Business Improvement Areas (BIA)? A BIA is a group of businesses, within a defined geographic area, that work together on local improvements. Established under the Municipal Government Act of Alberta, BIAs are funded by an annual levy which is collected from the area's businesses by The City and transferred to the BIA board of directors as stipulated in the regulation. An interactive map and dashboard are available which provides information on where Calgary's BIAs are located, as well as demographic information, such as household lifestyle, income, people and businesses within the BIA. Facts About Remembrance Day

- Remembrance Day used to be known as 'Armistice Day'. This day observed the moment at the 11th hour, on the eleventh day, during the 11th month in 1918 that the armistice agreement ended the First World War
- In 1954, the United States renamed Armistice Day to Veteran's Day.
- The poet for 'In Flanders Field' was Lieutenant Colonel John McCrae. He was born in Guelph, Ontario and was a Canadian army doctor.
- 54 Commonwealth members and even others who are not members, such as France, Poland and Belgium, observe Remembrance Day.
- Did you know there is a poppy store on the official Legion website? You can find a variety of ways to show your remembrance during November, and year round. What a great way, as well, to support our brave Veterans.

Beyond the Royal Yacht Britannia Queen Elizabeth II's Connection to a Calgary Suburb

Calgary's Britannia community, located on upland above the Elbow River, is an attractive, mature neighborhood of well-kept homes and treed lawns.

In the heady days before World War 1 Calgary was claimed to be "the fastest growing city per capita on the American Continent". Various plans were laid out for Britannia (yes, the name goes back that far) including one where the streets were laid out in a grid pattern without regard for the cliff and considerable topography. These early dreams of development were not fulfilled. Today older Calgarians remember Britannia as a place from their childhood where they rode horses or shot gophers.

After two wars and a severe depression everything changed when oil flowed from the plains and people flowed to Calgary. In 1952, Elizabeth II was crowned Queen of England (and Canada). It was time to develop Britannia. The hills were graded and new streets with new names surveyed. Appropriately, the streets reflected the names of the royal family as well as such names as Britannia Drive, Coronation Drive, Crown Avenue and Imperial Way.

Before development in the early 1950's, Elbow Drive was only paved to Sifton Boulevard where the street car tracks terminated. At that time city planners, rather than developers, laid out the subdivisions, installed services and sold lots. Britannia was chosen to be the

first "upscale" community built since World War 2. Lots were offered first in 1952 in the range of \$4,000 to \$8,000. Considering that the average lot price was closer to \$250 these prices were high, and when coupled with an economic downturn, few sold. The city tried again in 1954. Lot prices were halved to about the \$2,500 to \$5,000 range. This time lots sold.

With its diverse architecture featuring conventional two stories, flattops, butterfly roofs, "contemporary" and ranch style, Britannia was judged fit for the Queen and on a bright summer day in 1959. As part of her city tour, she was driven along attractively landscaped Britannia Drive in an open car past applauding residents. After that the community was on the city bus tours for years.
